TO THE SPANISH SECURITIES COMMISSION

Fluidra, S.A. (the "**Company**"), pursuant to the provisions of section 228 of Royal Legislative Decree 4/2015, of 23 October, which passed the amended text of the Securities Market Act, hereby issues the following:

MATERIAL FACT

The Company has signed a liquidity agreement with the financial intermediary BNP PARIBAS, S.A. SUCURSAL EN ESPAÑA. Under this agreement, 68,888 shares were initially allocated amounting to 462,924.57 euros. Pursuant to this agreement, transactions were conducted until 24 October 2018, when it was temporarily suspended following the start of a Buyback Program of Company shares, as announced in material fact number 270.821 on 25 October 2018.

In compliance with the provisions of Circular 1/2017, Rule Four, section 2b), a summary is given below of the transactions conducted during the last quarter in relation to the liquidity agreement.
